Witnesses testify at murder hearing

TOWANDA — A Preliminary Hearing in front of Magisterial District Court Judge Jonathan Wilcox for three alleged suspects in a Springfield Township murder investigation was held on Friday, April 26, at the Bradford County Courthouse in Courtroom No. 1.

Bradford County Chief District Attorney, Richard Wilson, led the prosecution, against the three Defendants: Ronda Parker (represented by Bradford County Chief Public Defender, Patrick Beirne and First

Victoria Martin); Summer Heil (represented by Attorney Matthew Diemer); and, Terry Parker (represented by Attorney Cornelius Rotteveel).

In March of 2024, it is alleged the three Defendants were involved in the murder of 40 year old, Michael Pruitt, at 1404 Sawyer Road, in Columbia Cross Roads, who was killed, dismembered and burnt.

During the prosecution's opening statement, Wilson stated Terry Parker instructed Ronda Parker to lure Pruitt to Bradford

Assistant Public Defender, County to be killed. Wilson advised on March 8 or 9, Terry Parker 'finished' the job, by shooting Pruitt multiple times.

> Wilson commented on March 11, Ronda Parker sent her 18 year old daughter, who testified, numerous text messages and screen-shots, indicating someone was murdered.

> An enormous amount of documents and photographs were entered as Commonwealth Exhibits, including copies of numerous text messages from Ronda Parker, which indicated a pack and play had to

be burned and she was concerned about her children's safety. A screenshot stated, 'already got half of him in the bag but ran out of contractor bags.' Another text read, 'Terry, Clorox is not enough, it's everywhere.'

Ronda Parker told her daughter over the phone that Terry Parker killed somebody.

Corporal James Rapburn of Crime Unit of PSP Towanda, testified when he arrived at the scene, they discovered a garbage burn pile, with a smothering/ burning pile of human re-
